2024 Healthcare Summit Speakers



Mary Bartlett works as a patient advocate for Teva Pharmaceuticals. She is an advocate by profession but passionate by choice. She has spent over a decade using her voice to help those living with mental health conditions. Through lived experience and supporting family members, she shares her story, connects with others, and fights for positive change in the mental health community. She is an avid cyclist, recovering stand-up comedian, and published author. In her first novel, she marries her love of writing with her personal and professional experience with mental health.



Jamie Belsito founded Maternal Mental Health Leadership Alliance in 2019 to keep a focus on national policy around maternal mental health, and she currently is Director of Policy and Partnerships. Jamie has been a key advocate in passing two pieces of federal legislation to address the nation's maternal mental health crisis. Her grassroots advocacy efforts helped establish the National Maternal Mental Health Hotline and garnered funding for federal grants to create state programs addressing maternal mental health. A Boston native, Jamie previously served as a Trustee of Salem State University, as a Commissioner on the (MA) Ellen Story Special Commission on Postpartum Depression, and as a Board member of the Massachusetts March of Dimes. Jamie served the Massachusetts Legislature from December 2021 to January 2023, representing the 4th Essex District.



Sara D. Brown is the Director of Government Affairs at Prevent Blindness, overseeing all Congressional, public policy, coalition, and grassroots advocacy in Washington, DC on behalf of patients across the United States who live with vision loss and blinding eye diseases. Sara gained in-depth, practical knowledge of Medicare and value-based physician payment policy and its effect on medical group practices while leading the Medical Group Management Association (MGMA)'s response to the Obama Administration's implementation of the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA), as well as through a role with NRC Health advising hospital executives on improving patient experience. Sara began her career working for over 6 years with U.S. Senators Jim Webb (D-VA) and Chuck Hagel (R-NE). A Nebraska native, she holds degrees in English and Political Science from the University of Nebraska-Kearney and a master's degree in public administration, focusing on the role of government, nongovernmental organizations, and the private sector in defense and foreign aid policy, from Walden University.



Senator Cristina Castro represents the 22nd District of Illinois and is the Majority Caucus Whip for the 103rd General Assembly and is chair of the Senate Executive Committee. She is a second-generation Mexican-American and lifelong district resident who is committed to her community and to public service. Castro's public service career began in 2008 when she was elected to the Kane County Board where she served until 2016. In addition to the Kane County Board, she served on the board of directors for the Illinois Housing Development Authority, Black History Family Festival and Centro de Información. With her marketing and communications management background, Castro has held positions in both the public and private sector. In 2015, she decided to run for the Illinois State Senate with the intention of using her professional background, life experiences and compassion to represent the interests and concerns of the people of the 22nd District.


